Memorandum of Understanding between

This memorandum of understanding is made between **Sacred Heart College, Tirupattur, Vellore Dt., TN, India,** represented by Rev. Dr. K. A. The autonomy has enabled the college, to establish itself as a pioneer in the field of "English proficiency education and has been rendering yeomen service to the youth of the rural and poor youth of the locality. The expertise so gained is unique in its nature and the college is confident that the methodology and the techniques of their English proficiency education could be gainfully used in other parts of India and the world. In this context, the English department of the college has been successful in providing consultancy service for developing English proficiency in other parts of the state as well. This concern of empowerment of youth being common to both these organisation, the Sacred Heart College (Autonomous), Tirupattur, Vellore Dt., TN, India, has now agreed to render their expertise in the form of their consultancy, cooperate in teaching, prepare necessary textbook, teaching manuals, reading materials, etc.

Now, by this memorandum of understanding, the Sacred Heart College (Autonomous), Tirupattur, Vellore Dt., TN, India, agrees to provide and support the English language learning proficiency courses organised by the Salesian Province of St. Joseph, Sri Lanka, on the following terms and conditions.

- 1. That the consultant institution will provide its expertise in innovative English language teaching.
- 2. That the PG and Research Department of English, Sacred Heart College (Autonomous), Tirupattur, Vellore Dt., TN, India, will train the staff and students in the institutes run by the Salesian of Don Bosco in Sri Lanka, in Professional and general English communication.
- 3. The Objectives, Methods, Manner, Duration, and Personnel of the training shall be mutually agreed upon between both the parties as mentioned above.
- 4. The material resources required for the Professional and general English communication shall be prepared and supplied by the PG and Research Department of English, Sacred Heart College, Tirupattur, Vellore Dt., TN, India.

- 5. The expenditure for all such material preparation shall be borne by the Salesian Province of St. Joseph, Sri Lanka.
- 6. The PG and Research Department of English, Sacred Heart College, Tirupattur, Vellore Dt., TN, India, shall assess and certify the eligible candidates in Professional and general English communication.
- 7. It shall be the responsibility of the Salesian Province of St. Joseph, Sri Lanka, to provide ample time, space, and support for the training programme as mutually agreed from time to time.
- 8. It shall be the responsibility of the Salesian Province of St. Joseph, Sri Lanka, to formally invite the consultant or any person recommended by the consultant for the training programme, to assist in obtaining the travel papers, to arrange for the air travel, and to remunerate the personnel involved in the training programme.
- 9. It shall be the responsibility of the Salesian Province of St. Joseph, Sri Lanka to provide boarding and lodging facilities for the personnel involved in the English training programme as recommended by the consultant, Sacred Heart College (Autonomous), Tirupattur, Vellore Dt., TN, India.
- 10. The consultant undertakes to ensure that all necessary teaching material and personnel will be made available as per mutually agreed terms and conditions and time-schedules.

This memorandum of understanding shall come into effect immediately and shall be valid for a period of three years. The parties shall be free to renew or amend the understanding on mutually agreed terms thereafter.
