MEMORANDUM OF UNDERSTANDING [MoU]

This MEMORANDUM OF UNDERSTANDING (MoU) is made and entered into force this 13.09.2021 between Sacred Heart College (Autonomous), Tirupattur represented by its Principal herein after referred to as SHC which expression shall where the context so admits mean and include its successors, representative and permitted assigns of the First part.

and

REVA UNIVERSITY, Bangalore, represented by its Vice-Chancellor herein referred to as **RU** which expression shall, where the context so admits, mean and include its successors, representative and permitted assigns of the other part.

Preamble:

Whereas **SHC** being a reputed teaching institution has well qualified and dedicated faculty members, visiting faculty drawn from Industries, Universities and R&D institution. SHC with its high teacher to student ratio facilitates higher education for under graduates, post graduates and Doctorate degrees, health care and research leading to publication, R&D activities and public health services.

RU is a BSCIC certified university, which is a recognition received for its high-quality management system. The University is a QS rated GOLD Band University and is also a NIRF ranked University and positioned 3rd in Karnataka by K-SURF, Govt. of Karnataka. RU is an accredited by International Accreditation Organization (IAO) and is a member of International Accreditation Council of Business Education (IACBE).

Whereas both SHC and RU are convinced about the mutual benefit of forgoing formal linkage to develop new collaborative academic and research programmes in the areas of health science-related programs that are involved in biomedical research. Now, therefore, in consideration of the premises and mutual covenants herein after contained the parties hereto agree as follows:

Scope of Work and Responsibilities:

The two parties after considering their objectives and strengths have agreed to have an understanding for collaboration in the following areas of interest:

- To promote and enhance academic, research interest between SHC & RU.
- To provide summer training for UG and PG students during their course and providing professional manpower to support the programme.
- Provide academic interaction by delivering special lecturers at SHC & RU on topics of relevance to current research trends.
- Organizing and participating in joint Symposia/Conferences/Workshop/Short term refresher courses.
- Exchange of faculty for guest lectures.
- This Memorandum of Understanding shall be valid from the date of signing of the same.

DECLARE THAT:

SHC and RU manifest their intention to reach an agreement to foster academic cooperation according to the following terms and conditions:

ARTICLE 1. SHC and RU agree to promote joint teaching, research, and other academic activities as aforesaid in the objectives and technical area of collaboration for mutual benefit to both institutes.

A Specific plan and agreement will be worked out and approved by the institutes before any such programs or activities can be undertaken.

ARTICLE 2. Resources for the implementation of specific programs may derive from either party or from external funds. However, this agreement does not oblige either party to expend any resources in connection with the objectives herein specified unless explicitly stated otherwise in the corresponding specific agreement.

ARTICLE 3. This agreement will be effective for a period of five years from the date of its signing and the renovation will be requested for the next period unless otherwise specified by the signing institutions.

ARTICLE 4. This agreement does not imply any financial duty upon both the institutions.

ARTICLE 5. Either party may terminate this agreement on written notification. Such notification must be given at least six months prior to the proposed date of termination. If the present agreement is terminated, both parties must guarantee to facilitate the completion of the projects and initiatives already in progress.

ARTICLE 6. Each institution appoints a coordinator for the implementation of this agreement, who will be responsible for defining and organizing the programs to be undertaken and for interaction between the two institutions.

ARTICLE 7.

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case basis and will be consistent with officially laid down IPR polices of the two institutes.

This MOU is executed in duplicate with each copy being are official version and having equal legal validity. By signing below, the institutes, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, comes into effect on the day it is signed.

ARTICLE 8. Each institution appoints a coordinator for the implementation of this General Agreement, who will be responsible for defining and organizing the programs to be undertaken and for interaction between the two institutions.
