NOW THIS DEED WITNESSETH AS FOLLOWS:

Objective:

The Objective of this agreement is to offer Post-Graduate Diploma in Youth Development (RGNIYD) launched by RGNIYD in order to professionalize youth work in India in collaboration with the Partner Institute.

2. Roles and Responsibilities of RGNIYD and Partner Institutions:

RGNIYD is offéring Post-Graduate Diploma in Youth Development in partnership with various educational institutions in the country as Partner

Institutions such as Central Universities, State Universities, Reputed Colleges and Departments, NSS Units, and NYK Centres.

Operational Strategies

Mode of delivery will be in convergence/blended mode. Through this mode of delivery, the learner can be facilitated with both the modes of learning which includes conventional as well as open and distance learning. For reaching the unreached, this mode of delivery will be highly suitable and comfortable to the learners. The following roles and responsibilities have been prepared to jointly deliver the programme and shall be followed by the Head Quarter, RGNIYD and SACRED HEART COLEGE (Autonomous) in the delivery of the programme.

II) Roles and Responsibilities of RGNIYD:

- a) RGNIYD is responsible to prepare the study materials and supply the same to the learners and also designing promotional material and disseminating the same to the Partner Institutions;
- b) Preparation of guidelines for smooth execution of the programmes is the responsibility of RGNIYD;
- c) Developing field activity manual to properly conduct the field work
 of the programme and every learner should be supplied with a
 manual;
- d) Collaboration with Educational Institutes, Development
 Organisations, NSS Units, NYKS in the country;
- e) Necessary technical support to Partnering Institutions (if needed);
- f) Setting guidelines for examination including question paper setting, evaluation and declaration of results etc.
- g) Certification will be done by RGNIYD and feedback from the Partnering Institutions and learners will be collected time to time; and
- h) Review of the programme will take place as per the guidelines.

III)Roles and Responsibilities of PARTNERING INSTITUTIONS:

- a) Overall Execution of the programme is the prime responsibility of the SACRED HEART COLEGE (Autonomous) Institution.
 Designing promotional strategies and reaching the large number of targeted participants shall be the responsibility of Partnering Institutions;
- b) Conducting meeting with various stakeholders of the programme and identifying Academic Counsellors and Field Work Supervisors;
- c) Contact classes should be conducted by the Partner Institutions.
 Suitable persons with adequate qualification should be appointed as the Academic Counsellors. Before engaging them to take classes, prior approval should be obtained from the RGNIYD;
- d) Supervision, Monitoring and Evaluation of field activity of the learner and submitting to Head Quarter;
- e) Evaluation of assignments, and field activity reports should be submitted to Head Quarter;
- f) Following the guidelines of RGNIYD and communicate from time to time;
- g) Appointment of a co-ordinator. Attending meetings at Head Quarter. The Head Quarter will call for meetings whenever it is required;
- h) Getting ready with all facilities to conduct examinations; and
- i) Assistance in executing any other programmes of RGNIYD
- The Partner Institutions shall reach a minimum number of enrolment i.e. 50 students and RGNIYD will consider those institutions as approved

examination centres after taking necessary approval from the competent statutory bodies of RGNIYD.

4. Terms of Payment:

The RGNIYD shall share 50% of the fee collected from each student enrolled to the SACRED HEART COLEGE (Autonomous) Partnering Institute on the following terms:

- The financial assistance is divided into various categories including fee sharing, remuneration to the coordinator, remuneration to academic counsellors, administrative cost and miscellaneous expenditure.
- The following guidelines are applicable to only those partnering Institutions which are sure of enrolling a minimum 50 students.
- iii) As part of collecting fee from the learners, the RGNIYD will collect Rs.5000/- (Rupees five thousands only) from each learner and 50 per cent of the fee i.e. Rs.2500/- (Rupees two thousand five hundred only) will be given to the Partner Institution. If a minimum of fifty students are enrolled with the partner institution, the fee sharing will be approximately around Rs.1.25 lakhs.
- iv) For smooth conduct of the programme at the Partnering Institutions, RGNIYD will provide Rs.5000/- (Rupees five thousands only) per month as honorarium to the co-ordinator of the Partnering Institute.
- v) The contact classes will be conducted at the Partner Institutions. In total the partnering Institute SACRED HEART COLEGE (Autonomous) has to conduct classes for 28 credits (8 theory courses) which come around 420 hours of teaching and learning.
- vi) Each session will be for two hours. The partner institutions will meet the expenses from the revenue generated through fee payment sharing.



 - Physics
 - Chemistry and Bio Chemistry
 - Nano technologies and nanomaterials
 - Material Science

2. Technical Area of collaboration

a) Joint research activities including the participation in national and international projects.

- b) Provide necessary support for the establishment of research Labs, training and placement, library and infrastructure.
- Provide academic interaction by delivering special lectures at SHC and SSNRC on topics of relevance to modern society.
- d) Exchange of scientific and technological information, joint publications of common results.
- e) Encourage the motivated research students of SHC to come for internship programs at SSNRC and vice versa.
- f) Organize summer training programs for final year students of SHC at SSNRC and vice versa.
- g) Facilitate the hands on training for PG students and research scholars.
- h) To exchange the visiting national and international delegates to each institute mutually
- The faculty members and research scholars of SHC can use the research facility of SSNRC and vice versa.
- j) Both institutes agree to help, identify and invite the faculty members and researchers from the other institutes to participate in conference, workshops, and short-term courses

Further, specific details for the implementation of these activities will be developed mutually for specific projects.

3. Proposed Modes of Collaboration

SSNRC and SHC propose to collaborate through the following:

- a) Cooperation and promotion of education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between SSNRC and SHC.

A Specific plan will be worked out by the Institutes depending upon availability of resource.

A specific agreement will be entered into for each activity.

4. Terms and Conditions

a) The cost of development of infrastructure at any Institute should be borne by the same Institute. b) This MOU may be amended, renewed and terminated by mutual written agreement of the Institutes at any time.

c) Either Institute shall have the right to terminate this MOU upon 60 days prior written notice to the other Institute.

5. Duration of MOU

This MOU, unless extended by mutual written consent of the Institutes, shall expire on completion of FIVE years from the effective date specified in the opening clause. However, on review, the MOU shall be extended for another TWO years by mutual consent.

6. Coordinators

Both Institutes will designate a person who will have responsibility for co-ordination and implementation of this agreement.

7. Intellectual property Rights

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case-to-case basis and will be consistent with officially laid down IPR polices of the two Institutes.

8. Signed in Duplicate

This MOU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the Institutes, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.



STUDENT ACADEMIC EXCHANGE AGREEMENT BETWEEN THE UNIVERSITY OF ALCALA (ALCALA DE HENARES, MADRID, KINGDOM OF SPAIN)

On the one part, Dr. Miguel Ángel Sotelo Vázquez, Vice-President of International Relations, acting in the name of the University of Alcalá, , in virtue of the competences attributed by the Excellent Headmaster (Resolution from 18th March 2014. BOCM [Spanish abbreviation of: Boletín Oficial de la Comunidad de Madrid] nº64 page 41, 17th March 2014).

and on the other part, Rev. Dr. D. Maria Antony Raj, the Principal acting in the name of the Sacred Heart College, Tirupattur, Vellore District, Tamil Nadu in India.

Both parties recognize each other's legal capacity to sign this agreement and

DECLARE THAT:

The University of Alcalá and the Sacred Heart College manifest their intention to reach a Student Exchange Agreement according to the following terms and conditions:

A. SCOPE OF THE AGREEMENT

The aim of this Agreement is to regulate the conditions that will allow students from both universities to study at the other university for one or two academic semesters. Both institutions agree to recognize and grant academic credits for the courses taken at the partner university. Detailed conditions regarding the studies to be pursued by students participating in the exchange shall be specified in individual student agreements, known as Learning Agreements, which must be prepared by the academic coordinator for the home institution and signed by authorized representatives of both institutions.

B. NUMBER OF STUDENTS

During the period of validity of this Agreement and beginning in the academic year 2017-2018, each of the signing universities may send to the other university a maximum of 2 student for a year-long stay or 4 for a one-semester stay. These students are exempt from the obligation to pay tuition fees in the host institution.

C. APPLICATIONS, SELECTION AND ADMISSION OF STUDENTS

Application for participation in the Student Exchange Program will be conducted in accordance with the following principles:

Students from the Sacred Heart College – Tirupattur, should possess prior knowledge
of the language of instruction of the courses that they plan to take at the University of

Alcalá equivalent to or higher than the B2 level of the European Framework of Reference for Languages. Exchange students aspiring to study Hispanic Studies at the University of Alcalá should possess prior knowledge of Spanish equivalent to or higher than the C1 level. Students of English Studies or Modern Language and Translation should possess prior knowledge of English equivalent to or higher than the C1 level of the European Framework of Reference for Languages.

- Notwithstanding the aforementioned, international students who have not acquired the linguistic abilities required to take degree-seeking courses at the University of Alcalá, but whose knowledge of Spanish is sufficient to follow academic lessons in that language, may take courses taught at the University of Alcalá specifically for international students in their field of study.
- The sending institution should guarantee that the candidates chosen to participate in this Program meet the language requirements.
- Each university will submit to the corresponding office of the receiving institution, the
 list of students selected for participation in this program not later than 30th of April of
 each year for students applying for admission during the first semester of the
 following academic year. The deadline is 30th of September for students applying for
 admission for the second semester.
- The final decision for admission is always at the discretion of the receiving institution, which can deny admission to any of the students proposed by the sending institution.

D. RESPONSIBILITIES OF STUDENTS AND UNIVERSITIES PARTICIPATING IN THE AGREEMENT

- Students are required to subscribe comprehensive health and accident insurance for the entire duration of their stay at their own expense. This insurance should also cover all expenses pertaining to repatriation to the country of origin in case of death or severe injury.
- Students will be responsible for travel costs to and from the university of destination and all other expenses not expressly stipulated in the previous sections of this agreement, including accommodation, books, consumables and all other expenses arising from the exchange.
- Following the completion at the host institution of the studies stipulated in the Learning Agreement all students should return to their home university. Any extension of their stay should be approved by both universities.
- Students participating in this Programme shall be subject to the rules and regulations
 of the host institution during the entire duration of their stay. They will also have the
 rights and privileges enjoyed by other students enrolled at the host institution.
- When necessary, the host institution will provide all relevant documentation needed to
 obtain student visas.

 Both universities will facilitate and support all applications for grants from national or international institutions which may provide financial support for this exchange.

E. DURATION OF THE AGREEMENT

This agreement shall remain in effect for a period of 4 years from the day of signing. Its renovation will be requested for the next period as long as neither party wishes to terminate it. A minimum period of six months' notice in writing will be required from either party wishing to terminate the agreement. In the event of termination, all commitments to students participating in the Program will be honored by both parties.

F. FINANCIATION

This agreement does not imply any financial duty upon the University of Alcalá.

G. AMENDMENTS AND CHANGES

Amendments or changes to this Agreement shall be approved by both parties and need to be signed by authorized representatives of both institutions.

H. ACADEMIC AND ADMINISTRATIVE COORDINATORS

Each institution appoints a coordinator for the implementation of this Agreement, who will be responsible for defining and organizing the programs to be undertaken and for interaction between the two institutions.

If the programme is scheduled to be conducted at the campus of Party B, the necessary accommodation and food arrangements for the resource person(s) are the responsibility of Party B.
- iv) Logistics: If the decided venue is the campus of Party B, the Party B has to ensure the logistic arrangements for the training including smart classroom. If the decided venue is the campus of Party A, the Party B has to pay a sum of Rs.1000/- day, a fees charged by the School of Economics, Madurai Kamaraj University for the use of its seminar hall.
- Refreshment for participants: Party B may need to make necessary arrangement like food, travel and refreshment for the participants.
- vi) Certificate: If the certificates are to be issued then the cost of printing the certificate would be borne by the Party B.

V. It is mutually understood and agreed by A and B between the Parties that:

- Modification: The Party A reserves the right to cancel or suspend any class, change start/end dates, timing of the class and arrange teachers, due to any unexpected circumstance.
- 2. Termination: In case of any of the violation of clause in the above agreement the MoU will automatically called for restoring termination or can be restored by the mutual consultation leading to agreement (between A and B).

Part C Exclusive Responsibility

Funding (Budget)

 Period and Venue of the Training: The time of the training and venue of the training programme is to be decided through mutual consultation between Party A and B. ii) Funding: Mobilizing or generating fund for organizing/conducting the said training programme is the sole responsibility of the Party B; the Party A does not have any sole/shared responsibility in fund mobilizing or generating.

VII. Effective Date and Signature

Responsibilities

The parties will consider and specify the responsibilities individually and jointly, and enumerate the details which constitute as the basis of a specific agreement entered into every area of cooperation giving a practical orientation to the objectives of the Memorandum of Understanding. This concept note is a preliminary draft presenting the idea whether resources available in both institutions can be shared for the mutual benefit of all concerned. Specific details regarding financial, technical, operational and administrative issues that arise out of the MoU will be taken up later on mutual consent once the possibility of joint collaboration becomes feasible.

Areas where sharing of resources could be thought of:

- Student Exchange Programme:
 Some of the papers in the Syllabus (Basics of Youth Development, Youth Policies & Programmes, Youth and Community Work, Project Management, Working for NGOs) are common for the students both Institutes.
 Student exchange programmes can be organized on some of these common areas which will enable students to interact and learn from one another and from faculty of the other institution. This also would provide scope for multi cultural exposure, sharing of experiences and diverse learning.
- Field Practicum: Dept. of Social Work, as part of the curriculum sends students for field work
 practicum for around 30 days in each semester in all the 4 semesters and also during the summer
 holidays (May) after the completion of II Semester.
- Certification Workshops on Project Formulation and Fund Raising:
 Workshops with practical exposure on Project Formulation, developing funding
 proposals, use of Logical Framework Analysis, PRA techniques, Spirituality of Social Work
 and Fund Raising strategies could be jointly organized for the students. Some of the faculty
 members of Dept. of Social Work, Sacred Heart College (Autonomous) conduct these
 courses as resource persons to NEISSR and vice versa.
- Use of Library & Exchange of Academic Information
 Books, journals and Online Resources could be used by students and staff members of both institutions.

 Joint seminars could be organized for the research scholars of M.Phil and Ph.D on Research Methodology, Statistics and SPSS (Statistical Package for Social Sciences.

- Publication (Journal & Co Authored Books)
 The faculty of P.G. & Research Dept. of Social Work and NEISSR can support each other in editing, peer reviewing of journal articles, book reviews, and in publishing articles. The expertise of the faculty could be harnessed in writing books, where there is paucity of relevant books on the curriculum.
- Faculty Exchange Programme:
 Short term faculty exchange programmes could be thought of in the areas of guest lectures on their areas of expertise, study and research.
- Joint Bidding for Proposals on Action Research Projects:
 Both the institutions, putting their expertise and resources together can bid for Joint proposals to Universities abroad on Action research projects concerning both institutions.
- Conducting Collaborative Research & Evaluation Projects:
 This could be an area of collaboration between both institutions.
- Policy Formulation and Advocacy
 Both the institutions have a major role to play in the policy formulation and advocacy concerning youth and youth issues.
- · Other activities as may be mutually agreed.

Article III. Implementation of Collaborative/Cooperative Projects, Programs and Activities

Specific details of any cooperative/collaborative activities to be conducted will be described and agreed upon in writing as Addenda to this MOU. Such Addenda will include the specific activities to be conducted; responsibilities of cooperating Parties; personnel, who will participate, lead and participate in such activities; allocation of time and resources required; implementation procedures; and other details as necessary. The two schools agree that they will be free to participate in projects acting either individually, or collectively.

Article IV. Intellectual Property

In the case that research results impacting upon matters of intellectual property rights are expected to arise in the course of collaborative projects carried out under the terms of Article I above, the parties shall discuss in good faith and agree in a separate document the conditions regarding the treatment of intellectual property rights so arising, prior to the start, of the collaborative project in question and in accordance with the policies of each party.

Article V. Cooperation with Third Parties

The two aforementioned schools may identify other agencies or institutions for joint participation in mutually agreed upon projects and activities and will be defined in writing for mutual agreement. Each center may individually execute cooperative and collaborative research,

education, economic development and other activities with other organizations independent of this MOU and of each other.

Article VI. Support and Resources

This MOU does not obligate either P.G. & Research Dept. of Social Work, Sacred Heart College (Autonomous), Tirupattur, Vellore. Tamil Nadu or North East Institute of Social Science and Research (NEISSR) 797112 Dimapur, Nagaland to provide funds and/or other resources from its own or other sources unless agreed to in writing. Each school may jointly or individually seek funding and other support from third parties for the conduct of collaborative projects, programs, and/or activities.

Article VII. Duration, Termination and Modification of Agreement

This MOU shall take effect when signed by the official representatives of the institutions involved and will remain in effect for an initial period of five (5) years and may be extended by mutual agreement in writing for additional five (5) year periods. Either Party may terminate this MOU with six (6) months written notice of intent to terminate. Such termination will not adversely affect programs in progress, other than by mutual agreement. Any modification shall require the prior written approval of P.G & Research Dept. of Social Work, Sacred Heart College (Autonomous), Tirupattur and North East Institute of Social Science and Research (NEISSR) 797112 Dimapur, Nagaland INDIA or their designees.
