The College is celebrating its 75 years of service to uplift of the Rural and Semi urban youth around Tirupattur. College that began with 80 students initially, has grown into an institution having more than 5000 students in various UG, PG, and Research Programmes and importantly celebrates its Platinum Jubilee, this year.

About The Department

The Department of Economics is the earliest department in the college that started as an under graduate course in 1956. Similarly the post graduate course (M.A.) was started in 1986. The department was upgraded as a research department in 1992. It has very rich and qualitative outcomes through Ph.D., programme and about 20 Scholars were awarded their Doctorate in Economics. The alumni of the department have occupied very important positions all over the country and abroad. The department concentrates on research activities apart from the regular teaching programmes.
